## **ORDINANCE 09-21**

## AN ORDINANCE AMENDING ORDINANCE 05-21, FIXING UTILITY RATES AND DECLARING AN EMERGENCY

**WHEREAS**, the Village of Frazeysburg by its Utility Department provides sewer utility service for the Village of Frazeysburg and surrounding areas; and declaring an emergency;

**WHEREAS**, the Village of Frazeysburg has determined that it is necessary to collect additional revenue to properly maintain the sewer infrastructure and continue with a 3% increase for the next 10 years:

## BE IT ORDAINED, BY THE COUNCIL OF THE VILLAGE OF FRAZEYSBURG, OHIO, THAT:

**SECTION ONE:** The Village of Frazeysburg, Ohio, hereby amends Ordinance 05-21, attached hereto and incorporated by reference as follows:

**SECTION TWO:** Establishing rates for the Sewer Utility provided by the Village of Frazeysburg. The following rates will be billed monthly.

- The price to be charged for sewer service furnished by the Village of Frazeysburg Sewer Department to all customers in the Village of Frazeysburg, Ohio are based on metered water usage and hereby fixed as follows:
  - a) Monthly minimum charge when there is no usage shall be set at \$14.68 per month
  - b) Monthly minimum charge (1-1,000 gallons) \$28.57 per month
  - c) \$7.57 per thousand gallons for the second thousand gallons (1001-2000)
  - d) \$5.15 per thousand gallons for gallons of usage above 2,000 gallons

2. The price charged for storm water service is \$2.50 per month.

- 3. All utility bills not paid by the fifteenth of the month will be assessed a late fee of fifteen percent (15%) of the most recent charges.
- 4. Each of the sewer charges shall be increased by 3% each year beginning with the August 2021 bill to comply with the Village Water Asset Management plan. The increase will be for a period of 10 years beginning with the August 2021 bill.

**SECTION THREE:** If any sentence, clause, section or any part of this ordinance is found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality or invalidity, shall affect only such clause, sentence, section or part of this ordinance and shall not affect or impair any of the remaining provisions, sentences, clauses, sections or other parts of this ordinance. It is hereby declared to be the intention of the council of the Village of Frazeysburg that this ordinance would not have been adopted and such unconstitutional, illegal, or invalid sentence, clause, section or part thereof been included therein.

**SECTION FOUR:** All ordinances or resolutions in conflict with this ordinance are hereby repealed to the extent of the conflict.

**SECTION FIVE:** That this Ordinance is declared to be emergency legislation, necessary for the immediate preservation of the public peace, health, and safety, which shall be effective upon passage, such emergency arising from the need for the Village to collect necessary revenue for maintenance of utilities.
